- 2019 CACD Annual Meeting: 2018 Farm Bill will result in changes to FSA and NRCS programs. Elections for conservation districts will move to odd years starting in 2023. The 2020 budget and Annual Report will be available to view on DOLA website.


Poster Contest:

The district is currently offering to cost share the purchase of CoCoRaHS (Community Collaborative Rain, Hail and Snow) gauges. Data reported to the CoCoRaHS system is used to help monitor drought conditions in our area. Parties interested in purchasing a gauge with the intent of faithfully reporting data are encouraged to contact the district for additional information.

Services Available

The Agate Conservation District is continuing its partnership with the Double El Conservation District to lease equipment to help mitigate prairie dog infestations. The Pressurized Exhaust Rodent Control (PERC) machine is available to landowners in the area for a rate of \$25.00/hour (\$100.00 minimum).
